- Papers for the conference should be submitted to <u>sbfc.conference@sydney.edu.au</u> with the subject line "SBFC2023 Submission". The deadline for paper submissions for the conference is **August 31, 2023**.
- Authors will be notified by September 20, 2023, whether their papers have been accepted for presentation at the conference.

• The conference is open to a small number of special sessions, each containing three papers, organised by interested researchers proposing a theme-based session within the overall theme of the conference.
